


FDI inflows to the Asia-Pacific



- FDI inflows to the Asia-Pacific region contracted by 3% to \$541 billion in 2016
- A-P's share of global FDI inflows: 31% in 2016
- Still developing A-P accounted for 74% of FDI inflows to developing economies worldwide




FDI outflows from the Asia-Pacific



- FDI outflows from the Asia-Pacific region increased by 10% to \$495 billion in 2016
- Slightly picking up from 2015's low level




Greenfield FDI flows: Asia-Pacific region



- Greenfield FDI inflows increased by 12% in 2016, accounted for 43% of global greenfield FDI inflows
- Greenfield FDI outflows also increased by 20%
- Positive signs: greenfield investment long-term investment and barometers of FDI contribution to local economic development: job generation, skills development, capital and technology transfer




Intraregional FDI flows



- Intraregional greenfield FDI inflows increased over the last decade, with annual growth rate of 4%
- Stagnated in 2016, with share of 48% in total greenfield FDI inflows to the region




Intraregional FDI flows



- ASEAN continues to attract significant amount of intraregional investment
 - Continued economic integration efforts
 - Relocation of investment from China (capturing labour-intensive productions and advantageous geographical locations)




FDI inflows: subregions



• Mixed performance among subregions and individual economies




FDI inflows: subregions - Highlights






FDI outflows: subregions



- Led by East and North-East Asia
- mainly China, Hong Kong (China), Japan




FDI inflows: sectoral



- Greenfield FDI inflows in the services sector increased by 31% in 2016
- Manufacturing: affected by industrial reconfiguration of the subregions' value chains



National policies on investment



- 43 policy changes related to liberalization, promotion and facilitation
- 9 new restrictions or regulations on investment






Promotion and facilitation of foreign investment

- 20 new IIAs signed and 5 entered into force
- Also some terminations of IIAs (Indonesia (11) and India (7))
